




**Candidates for Vice President** of Professional Development





# Candidates for Senior Vice President



### JACK H. DOBSON JR.,

CSP, is senior vice president of Safety & Health Associates Ltd., Cedarburg, WI. Currently operating his own business, Dobson provides consulting services in the areas of safety training, safety program auditing and development, and expert witness testimony.


His 34-year professional safety career began with the U.S. Air Force, after which he pursued a career in federal civil service. Holding civilian safety management positions with the departments of the Air Force, Navy and Treasury, he also served as a safety instructor at the OSHA Training Institute. He served on ASSE's staff as director of technical services. Dobson retired from the Air Force Reserve as the wing ground safety officer for the 440th Tactical Airlift Wing in Milwaukee. He holds a B.S./B.A. from Roosevelt University, and an M.A. from Webster University.

Development Committee, Dobson has also served
as Vice President, Council on Professional Affairs
(1999-2001); Administrator, Consultants Practice
Specialty (1997-99); Region V Vice President (199195); and is a past president of the Northeastern

A member of National Fire Protection Assn., National Safety Council, Wisconsin Council of Safety and International Society for Fall Protection, Dobson currently serves on two ANSI safety standards committees: Z117 Confined Spaces (member) and Z359 Fall Protection (chair). He also serves his community as an elected member of the Cedarburg School District Board of Education.

### JACK H. LUCKHARDT,

CSP, ARM, is principal of The Luckhardt Group, which provides safety and health consultative services to a wide range of industries, including heavy construction, educational institutions, healthcare facilities and funeral homes. Luckhardt



A member of ASSE since 1979, Luckhardt has served as president of both the South Florida Chapter (two terms) and the Triad Chapter. He recently served on the Society's Board of Directors as Vice President Region VI (1999-2002). Luckhardt is current chair of the Society Bylaws Committee and serves on the Fellow Review Committee. In addition, he has served on the Divisions Renewal Task Force, Body of Knowledge Task Force, Admissions Committee and House of Delegates Credentials Committee. Luckhardt is a recipient of both chapter and regional Safety Professional of the Year awards, and is a professional member of the Central Florida Chapter.



A critical position on the Society's Board of Directors, the senior vice president serves a one-year term, advancing to successive one-year terms as ASSE president-elect and president, respectively.

The senior vice president is responsible for regional functions, chairs the Council on Member and Region Affairs, and oversees chapters and sections outside the U.S. and its territories.

The president-elect oversees and monitors the activities of the council vice presidents for professional affairs, professional development, and practices and standards.

As chief elected officer, the president is primarily concerned with promoting the advancement of the Society and the safety profession, and representing ASSE before members, other relevant professional societies nationally and internationally, and various governmental agencies. This year's candidates for senior vice president are Jack H. Dobson Jr., CSP, and Jack H. Luckhardt, CSP, ARM. Their biographical information appears at left.



The Society has four councils: Member & Region Affairs, **Practices & Standards**, **Professional Affairs** and Professional Development. The Member & Region **Affairs Council is** chaired by the senior vice president. The other three councils are chaired by an elected vice president.

These two vice presidents are elected for two-year terms in odd-numbered years. The vice president, practices and standards, serves a twoyear term and is elected in evennumbered years. Biographical information on the four candidates for these council positions begins at right.

The vice president of professional affairs serves as the chair of the Council on **Professional Affairs.** The position is responsible for developing and implementing programs to place the Society in a leadership position in the management of the safety profession, including recognition of the safety professional and enhancement of the profession. The VP also oversees development of professional and educational standards of practice, defines the safety profession and maintains the Society's publication, "Scope and Function of the Safety Professional."

### **Professional Affairs**



### **RIXIO E. MEDINA,**

CSP, CPP, is manager of corporate health, safety and security for CITGO Petroleum Corp., Tulsa, OK. He oversees the company's health services, product safety, industrial hygiene, safety and security functions and provides technical assistance on risk management and

regulatory compliance. Medina has more than 24 years' experience in comprehensive practice of health and safety in the petroleum and refining industries. Prior to joining CITGO, he was safety engineering supervisor for Mobil Oil Corp. in Joliet, IL, and environmental, health and safety superintendent for PDVSA, Venezuela. Medina holds a B.S. in Fire Protection and Safety Engineering Technology from Oklahoma State University, Stillwater, and an M.S. in Industrial Security from Central Missouri State University, Warrensburg.

A professional member of ASSE since 1991 and member of the Tulsa Chapter and the Engineering Practice Specialty, Medina has served as treasurer and secretary of the Imperial Calcasieu Chapter in Louisiana and chair, Governmental Affairs Committee of the Coastal Bend Chapter in Texas. Nationally, he has represented ASSE at the 2000 North American Occupational Safety and Health Week in Mexico City, the 2002 Mexican Assn. of Mechanical Engineers' Safety Conference in Guadalajara, and at safety conferences with the U.S. Dept. of Labor and the secretaries of labor, business leaders and labor unions in Belize, Guatemala, Nicaragua and Honduras.

Medina has served as chair of the Civil Service Commission for the City of Corpus Christi, and has served as a safety representative on the National Advisory Committee on Occupational Safety and Health since 2000.

### JAMES D. SMITH,

CSP, is director, risk control services for Arthur J. Gallagher—Boca Raton/Miami, FL. Prior to joining the Gallagher team, he was corporate safety, claims manager and environmental engineering for 18 years for an organization with assets exceeding \$1 bil-



lion. Smith holds a B.S. and an M.S. in Industrial Safety from Central Missouri State University. He is a certified safety professional by examination.

Smith has served ASSE in various capacities that have prepared him for this board position. They are: board member, Vice President, Council of Professional Affairs (two years); Council on Professional Affairs (four years); Charles V. Culbertson Outstanding Volunteer Service Award (1997); Finance Committee member (two years); Standards Development Committee Chair (six years); Council on Practices and Standards (two years); PDC Conference Committee (one year); Public Relations Task Force (presidential appointment); NIOSH/NORA Research Task Force (presidential appointment); ANSI Organizational Membership Council (ASSE representative); ANSI Standards Committee Representative (A14, Z10, A1264.2, Z490/Z590); expert reviewer for Professional Safety; chapter president (two terms); and Gold Coast Chapter Safety Professional of the Year (two-time recipient).

Cofounder of the Kittyhawk Section and Chapter, Brown served as president, vice president/treasurer, delegate



Brown was named Safety Professional of the Year by the ASSE All Ohio Council (1987) and ASSE Region VII (1988-89). He served as ASSE Region VII Vice President 1989-93 and 1997-2001. He currently serves as Vice President of Professional Development.

As a National Safety Council volunteer, Brown has served as general chair of the Electronic and Electrical Section, chair of the Engineering Standing Committee and chair of the Business and Industry Procedures Committee. He received the NSC's Distinguished Service to Safety award in 1992.

Brown serves on the Society of Ohio Safety Engineers' Pattern for Progress Committee, is pastpresident of AIHA's Ohio Valley Section and serves on the national AIHA Confined Space Committee. Daecher has served as assistant administrator and is currently Administrator of the Transportation Practice Specialty. He also serves as Vice Chair of the Council on Practices and Standards. # Candidates for Region Vice Presidents

## Region I



JOE S. ADAMS II, CSP, has been involved in the environmental health and safety profession continually for the past 30 years. As an aviation safety officer from 1971 to 1988, Adams functioned in numerous key positions including director of safety at the Army National Training Center, Ft. Irwin, CA. In 1988, he became the manager of safety at Kaman Aerospace and, in 1991, the director of risk man-

agement at the University of Alaska, Fairbanks. Adams is currently occupational and environmental health and safety coordinator at the University of California, Office of the President, Oakland.

Safety education includes USC Aerospace Safety, a B.S. in Aviation Safety, an M.B.A., Aviation, and three years of industrial technology. An adjunct professor with Embry-Riddle Aeronautical University, Adams teaches undergraduate and graduate courses in safety and management.

A professional member of ASSE since 1990, Adams was instrumental in the formation of the Midnight Sun Chapter. Elected in 1997 as the first region vice president for the newly combined Region I, Adams served two years in that office. He is a member of the President's Council, having recruited more than 50 new ASSE members

Bakersfield Branch, and a safety representative for Shell Oil Co. An ASSE member since 1995 and a professional member since 1998, Iriart has held various offices for the Bakersfield Section/Chapter. He was the first president of the new Bakersfield Chapter, serving a two-year term (1998-2000); the chapter received a Chapter Achievement Award during both years. Iriart was instrumental in initiating the chapter's Safety and Workers' Compensation Symposium, which is now a successful annual regional event. Iriart was named the chapter's Safety Professional of the Year (SPY) in 1999 and was nominated for Region I SPY in 2002.

Iriart is also active in his community. **RICHARD F. MOSCATO,** CSP, professional member of ASSE and a certified safety professional, is currently president of a safety consulting company and lives near Chicago.
